The deadline for nominations is December 12, 2022.

ELIGIBILITY

- Applicant must have an MLS degree from an accredited library or information science program.
- Applicant must be a member of SLA.
- Applicant may have no more than eight years of experience in an academic library position, with a main focus on business.
- The Business & Finance Community reserves the right to not distribute an award in the event that there are no qualified applicants.
