President's Report- Jane offered a big "thank you" out to Meryl and Jennifer for meeting in December, and then assisting Jane in getting Chapter 2016 Financials to SLA Accounting and Auditors by January 2017 deadlines. Chapter received confirmation reports have been received, and have not had any additional follow up from SLA HQ. We hope to hear soon of our 2017 allotment from SLA HQ, and this gets added to our SLA Chapter Investment Account.

Jane then gave a brief recap on the recent **Unit Communications Tools and Strategies** webinar, which included the **Unit Membership Toolkit**. The goal of the SLA HQ hosted webinars is "to support and equip you in your volunteer role as much as possible."

Jane reminded the group that the SLA Annual Conference registration is now open and is available to link to from both our SLA MI Chapter website and the Special Libraries Association website. Early Bird Registration is still available.

Jane, Joel and Jennifer Meekhof will meet offline to discuss putting the final draft of the Michigan Chapter Recommended Practices before the Membership, and have targeted to have amended document done by March 31, 2017. Jane realized she had not invited Judy Smith, representing University Michigan Library Students, and Jennifer M. representing the Wayne State University Library Students to join on the call. Updates to 2017 Michigan SLA program event plan details.

State of the library & information market. Recommendation – postpone until October or November. Interested in locating either solo speakers or panel participants who work directly with the job market could share their insight on who is hiring librarians and what types of skills are recommended to obtain employment or remain professionally relevant. This event would have to be held at the Ross School because we have FREE access to video conferencing technology and generous IT support.

Dee also suggested Jim Matarazzo, former Dean of Simmons I-School and Kim Dority who wrote a book on rethinking information work.

Since the contacts have yet to respond, this event can be hosted in September or October. If they do not respond, we can have a panel of SLA members who could discuss how they used their library skills in non-traditional settings. Anne has some good suggested candidates. I also have a few more other contacts to follow up.

Designing effective & visually attractive presentations. Met with a communications coach at the Ross School of Business whose group works with student presentation skills and sponsor relationships. She was interested in our topic and said that she will discuss this with her colleagues. I will follow up with her on Friday.

Emerging Technologies. Anne Herron had some concrete and very good event suggestions and maybe we can move forward on one of them for the later part of April. Anne suggested the topic of <u>Emerging</u> <u>technologies in Data Science & Information Fields</u>. Potential speakers: Mari W. Buche, Assoc Professor, Management Information Systems, Michigan Technological University and Amjad S, member of the National Center for Economic Gardening.

The SLA MI Chapter also looks forward to co-hosting workshop on *Data, Analytics, and Visualizations* on March, 17, 2017 with University of Michigan and the Maryland Chapter of SLA, at the University of Michigan.
