The Michigan SLA Chapter remains in good financial health with an overall balance of \$28,967.51. As of September 30, the checking account has a balance of \$17,848.54. Total Checking Debits (July 1 - September 30) were \$12, and credits were \$1318.58. The savings account has a balance of \$4,209.46, up .12\$ from interest earned. The investment account, managed by SLA and pooled with other chapters, has a balance of \$6,909.51.

## **6. Director's Report – Jane Potee**

Jane announced Sheila Bryant has volunteered for Secretary, Bryce Rudder volunteered for the Treasurer position, Jennifer Meekhof volunteered for Director, and Jane Potee is volunteering for President Elect. Jane has requested a short bio from each candidate. Voting will take place at the holiday party.
